**CASA's residential services include the emergency shelter that provides a safe refuge, crisis intervention and advocacy when home is not a safe place. In addition, shelter participants receive food, clothing, and personal items. CASA provided sanctuary to over 650 survivors with approximately 50% of those being children. A total of more than 38,800 bed nights were provided for survivors.**

**In addition to shelter services, CASA Outreach services reached over 2,000 survivors during the FY 2016-17 through its various programs providing basic living needs, advocacy, counseling, assistance and support to survivors and their families. (Continued on Schedule O)**

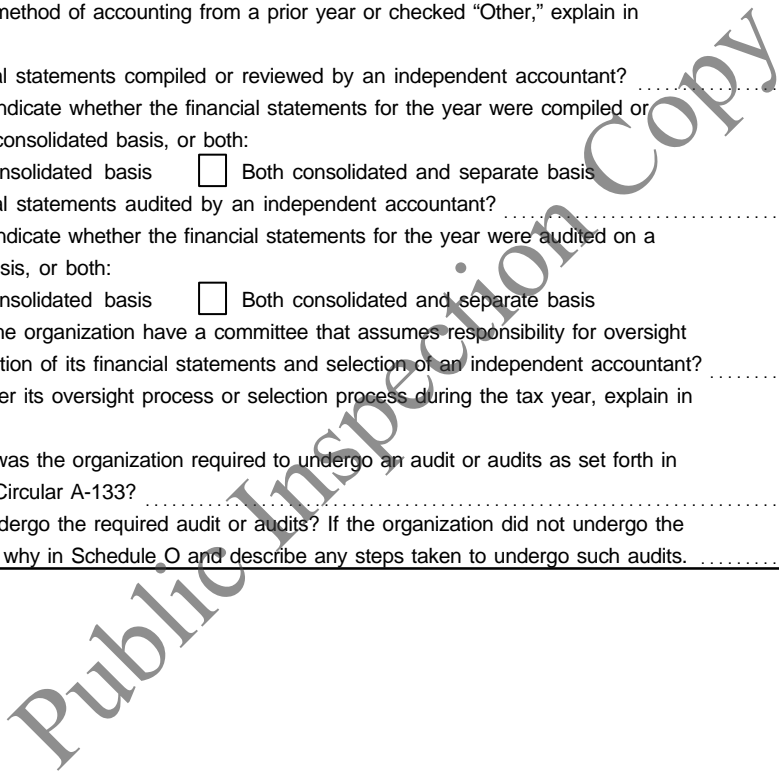

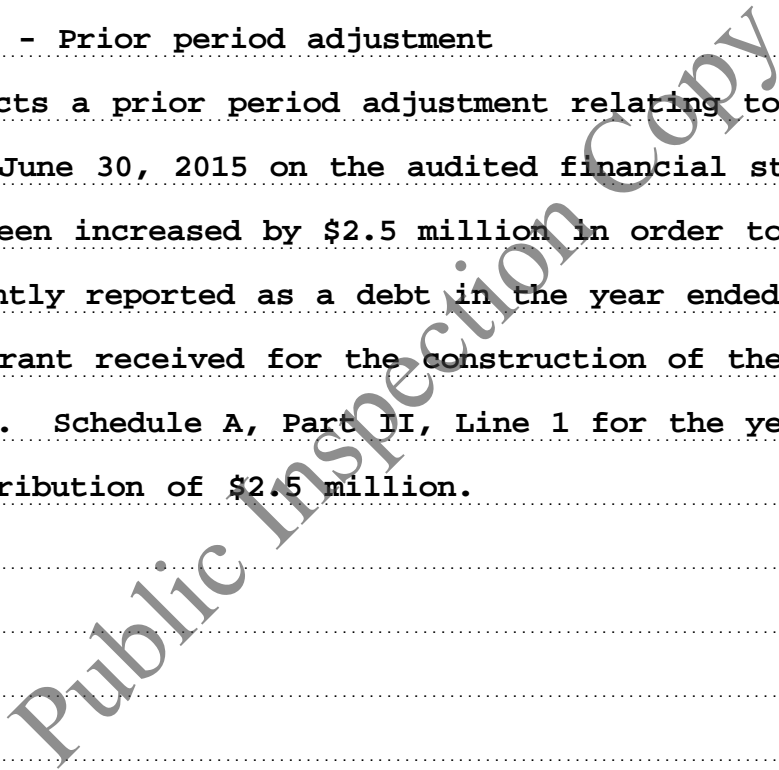

CASA works closely with the Pinellas County Sheriff's Office Child Protection Investigation Division to increase the safety of adult and child victims of domestic violence and helps to reduce the number of out-of-home child placements due to domestic violence through the CPID (Child Protective Investigation Division Program). CASA's Substance Abuse program recognizes the perilous interconnection between substance abuse and battering. Services are provided for children and families dually affected by domestic violence and substance abuse who participate in CASA's community support groups or in local substance abuse treatment programs. CASA offers assistance and support to survivors utilizing the civil and criminal justice systems. Staff meets survivors at the criminal court to assist with court proceedings. Staff also assist survivors at the Clerk of Courts making application for injunctions for protections.
